



Delhi Charter Township Transient Sales License Information

Ordinance No. 45, 45.1

For the safety of Township residents, any person (both principals and agents) who engage in temporary or transient business in Delhi Township by solicitation from door to door or selling goods or services from motor vehicles must obtain a Transient Sales License from the Delhi Township Clerk's Office.

Solicitation for bonafide charities, religious solicitations and school-related fundraising programs are exempt from obtaining a Transient Sales License. Non-profit groups should fill out the application and submit the required information for the benefit of both, the residents of Delhi Township and your organization. This will enable you to have a license for resident's review, which may ease any concerns of your legitimacy.

Please remember to respect the wishes of our residents and the peace of our neighborhoods. Those who are not interested, please move on. Music from ice cream trucks should not be so loud that residents hear the music for a prolonged period. Hours of operation shall not begin before 10:00 a.m. or proceed after 9:00 p.m. Complaints from residents may result in non-refund of the cash bond.

Any person engaging in transient sales business in Delhi Township, who is required to obtain a license and fails to do so, or has obtained a license and is violating the requirements of the Township's transient sales ordinance (No. 45, 45.1), shall be deemed guilty of a misdemeanor and subject to imprisonment in a County Jail for a period of up to ninety (90) days or a fine of Five Hundred Dollars (\$500) or both, plus costs as the Court shall determine.

Please complete the application, which consists of:

1. Name and Address (Permanent and Local) of Business
2. Length of time proposed for operation in the Township (not to exceed 6 months)
3. Year, Make, and License number of motor vehicle used along with copies of registration and proof of insurance for each vehicle.
4. Detailed description of goods to be sold
5. Copies of drivers license of each person selling

Fees:

- ◆ \$250 Cash Bond, returned to licensee 30 days after expiration of the license, subject to any claims by any resident of the Township
- ◆ \$25 (non-refundable) fee for each 30-day period that license is in effect.
