There is a stipulation in the SUP that indicates that the maximum operation times for these events is between 8am and 9pm. However, this year Corrigan Oil Speedway (Spartan Speedway) will be hosting The Greater Lansing Relay for Life. This is an event that people walk for loved ones for 24 hours' strait. It is Ms. Miller's interpretation that the SUP conditions relative to hours of operation did not apply to a quiet non-profit event like the Relay. Ms. Miller wanted to provide this information to the PC so that there was clarity regarding the decision and general agreement regarding the interpretation of the SUP condition.
